Osteopathy and Osteopathy Australia

Osteopathy Australia is the peak body representing the interests of osteopaths, osteopathy as a profession, and consumer's rights to access osteopathic services. Our core work is liaising with state and federal government, and all other statutory agencies, professional bodies, and private industry regarding professional, educational, legislative, and regulatory issues. Most registered osteopaths are members of Osteopathy Australia.

Osteopaths in Australia are university-qualified allied health practitioners registered with the Australian Health Practitioner Regulation Agency (AHPRA). Osteopaths complete either a dual bachelor or bachelor and master's qualification covering functions of anatomy, biomechanics, human movement, the musculoskeletal and neurological systems as well as clinical intervention approaches which are all underpinned by a biopsychosocial management approach.

Over 70% of consumers attending an osteopath are presenting with neck or back pain.
